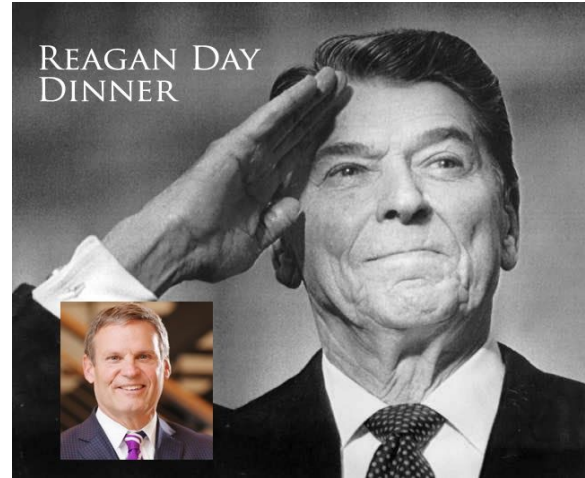
OUR MISSION
